- The shares are held directly by Accomplish Fund II, L.P. ("ACC II"). Accomplish Associates II, LLC ("ACC Assoc II") is the sole general partner of ACC II. Mr. Moore is a Managing Member of ACC Assoc II. Mr. Moore disclaims Section 16 beneficial ownership of all shares except to the extent of his pecuniary interest, if any, therein. This report shall not be deemed to be an admission that Mr. Moore is the beneficial owner of such securities for purposes of Section 16 or for any other purpose.
- Each RSU represents a contingent right to receive one share of the Issuer's Class A Common Stock.
- Represents RSU grant that is being issued in lieu of a quarterly cash retainer.
- The RSUs were granted and became fully vested on May 3, 2022.
