1. This disposition does not represent a sale of these shares by Mr. Sloan or any other person. In connection with the recent business combination among DraftKings, Diamond Eagle Acquisition Corp. and SBTech, the founders of Diamond Eagle placed certain "earnout" shares of Class A Common Stock in escrow that would be released to former stockholders of DraftKings Inc., a Delaware corporation, upon the satisfaction of certain post-closing conditions. Those conditions were satisfied on May 21, 2020, and the transfer of these shares represents the release of these shares from escrow, and not the sale of these shares by Mr. Sloan or any other person.
