144: Remarks and Signature

Remarks Seller represents that the sale reported in Table I of this Form was made subject to a stock purchase agreement in respect of a variable price forward sale transaction (the Forward Contract) between Seller and the broker named in Table I. The Forward Contract provides for settlement based on the closing price of the Issuer's Class A Common Shares on the maturity date, March 8, 2027. Any initial hedging activity in connection with the Transaction will be conducted by the broker named in Table I. As listed in Table II of this Form 144, Seller further represents that the sales of (i) 241,682 shares on December 12, 2023 and (ii) 242,478 shares on December 13, 2023 were made pursuant to a Rule 10b5-1 trading plan in order to cover tax withholding obligations in connection with the vesting of certain performance-based restricted stock units granted pursuant to the December 2020 LTIP.
