Explanation of Responses:

- Each restricted stock unit represents a contingent right to receive one share of the Issuer's Class A Common Stock. Pursuant to the internal policies of Revolution Growth Management Company, Inc. ("Revolution Management"), the economic value of these securities inures to the benefit of Revolution Management. Mr. Murray is a stockholder of Revolution Management and disclaims beneficial ownership of such securities except to the extent of his indirect pecuniary interest therein.
- Represents RSU grant that is being issued in lieu of a quarterly cash retainer.
- The restricted stock units were granted on August 12, 2020 and shall vest in full on the earlier of (i) the next annual meeting of the stockholders of the Issuer following the grant date and (ii) the first anniversary of the grant date.
- This Form 4 amendment is being filed solely to correct the number of restricted stock units granted by the Issuer to the Reporting Person on August 14, 2020. The original Form 4 filing erroneously reported 505 restricted stock units granted by the Issuer to the Reporting Person. The corrected number of restricted stock units granted by the Issuer to the Reporting Person is 393 restricted stock units. Other than as described in this footnote, there are no other changes from the original Form 4, including the transactions triggering the original Form 4.
